Instructions for the participants of "Training Programme for Referral Judges" on 28.07.2024 (Ist phase)

Following instructions need to be observed during the training programme-

- 1. For participating in the training, every participant must have <u>Google Meet</u> in their device with g-mail I.d. for compulsory registration of each participant.
- 2. Every nominated participant shall have to compulsorily register before 09:45 a.m. on 28.07.2024 via link "Training Programme for Referral Judges" under 'V.C. Timing & Link' available on the official website of the UJALA.
- 3. How to join the Video Conference:-
 - Click to the link of <u>Google Meet</u> available on the official website of the UJALA under 'V.C. Timing & Link' tab.
 - Login to your g-mail account.
 - Click 'Ask to Join/Join Now'.
- 4. The participants have to join the programme on the scheduled time i.e. 09:50 a.m.
- 5. The participants should not switch off/turn off the camera, unless instructed otherwise.
- 6. If any participant wants to ask any question after each deliberation, "raise hand" option should be clicked on. The resource persons will then take their queries one by one. All participants should not raise queries simultaneously.
- 7. Any participant SHOULD NOT click on "Share screen/ Present now" icon/button during the session.
- 8. Statutes relevant to the session/ study material (if any) provided by the Academy should be with the participants during the sessions.
- 9. The participants should keep their microphones off while the session is in progress, unless instructed otherwise.
- 10. The participants should not record the audio/video content of the training/workshop sessions or part thereof, by any means/modes whatever, unless instructed otherwise.
- 11. The participants should not entertain other person(s) to have an access to the training sessions by any means/mode whatsoever, as the training is purely individual and confined to the nominated participant only.
- 12. The participants be seated before their gadgets facing camera in such a way that they can be clearly identified by the Resource Persons/Session Coordinator.
- 13. Keep the mobile phone on silent/vibration mode, if the device is not being used for attending the programme.
- 14. Provide feedback on the format designed to evaluate the impact of training programme. The link for the feedback shall be made available by UJALA before the completion of the last session. The participants must submit feedback form after the completion of training before the midnight of the completion of training programme.
